The Skagit County Board of Commissioners met in regular session on Tuesday, September 23, 1997, with Commissioners Robert Hart and Ted W. Anderson present. Commissioner Harvey Wolden's absence was excused.

**PUBLIC WORKS DEPARTMENT – JAN KEISER, DIRECTOR.**

1. Public Hearing – Consideration of Amendment of Ordinance #15435 Changing the Skagit County Code Establishing a Revised Uniform System for Addressing Building, Reaffirming the Baseline for Addressing Purposes, Posting of Addresses, Naming Roads, Providing the Methods for Instituting Said System and for the Enforcement Thereof.

Rodney VanderSyden, Public Works Department Staff, reviewed the proposed changes to the existing addressing ordinance.

Jillian Sanctuary, Shelter Bay, stated that she talked to the Board approximately one year ago, and has received nothing in writing confirming that Shelter Bay is excluded from the readdressing process. She stated that she would like to receive official notification.

There being no further public comment forthcoming, Commissioner Anderson moved to close the public hearing. Commissioner Hart seconded the motion, which passed unanimously. The public hearing was closed.

Commissioner Anderson moved to approve the amendment to Ordinance No. 15435 as presented by Mr. VanderSyden. Commissioner Hart seconded the motion, which passed unanimously. **(Ordinance No. 16681)**

Mr. VanderSyden presented a related technical resolution concerning readdressing and explained that this proposed Resolution is a companion resolution to the previously passed ordinance. This resolution is an amendment to Resolution No. 15436. Commissioner Anderson moved to approve this technical resolution as presented by Mr. VanderSyden. Commissioner Hart seconded the motion, and it was unanimously approved. **(Resolution No. 16682)**

2. Public Hearing – Regarding Road Name Changes and Clarifications of the Following County Roads: Zyman Road #08550, Forest Road #08510, S.R. Young Road #46000, Main Street #22390, Samish Point Road, #39600.

Linda Leonhart, Public Works Staff, advised that the proposals before the Board today are housekeeping issues in conjunction with readdressing. She explained the various road name changes and exact locations.

There being no public comment forthcoming, Commissioner Anderson moved to close the public hearing. Commissioner Hart seconded the motion, which passed unanimously. The public hearing was closed.

Commissioner Anderson moved to approve the Resolution as presented by Ms. Leonhart. Commissioner Hart seconded the motion, which passed unanimously. **(Resolution No. 16683)**

3. Public Hearing – Consideration of Establishment of Chilberg Lane, #44249, as a County Road.

Ms. Leonhart described the exact location of Chilberg Lane, and the procedure for establishment as a County Road.

There being no public comment forthcoming, Commissioner Anderson moved to close the public hearing. Commissioner Hart seconded the motion, which passed unanimously. The public hearing was closed.

Commissioner Anderson moved to approve the Establishment of Chilberg Lane, #44249, as a County Road. Commissioner Hart seconded the motion, which was unanimously approved. The Board signed the Order of Establishment. **(Approved)**

4. Public Hearing – Consideration of Establishment of McDougall Street, #21239, as a County Road.

Ms. Leonhart described the exact location of McDougall Street.

There being no public comment forthcoming, Commissioner Anderson moved to close the public hearing. Commissioner Hart seconded the motion, which passed unanimously.

Commissioner Anderson moved to approve the Establishment of McDougall Street, #21239, as a County Road. Commissioner Hart seconded the motion, which was approved unanimously. The Board signed the Order of Establishment. **(Approved)**

5. Public Hearing – Consideration of Vacation of a Portion of Platted County Right-of-Way Known as Gilkey Avenue, #20010.

Ms. Leonhart described the exact location of Gilkey Avenue, which is the subject of today's hearing. She advised that Staff is recommending denial of the road vacation due to the receipt of letters and correspondence opposing such vacation.

Jane Kennedy, 1203 McTaggart Avenue, read her public testimony into the record. She reviewed her concerns of the lack of a turnaround area for area businesses. She advised that there is pressure for parking along Gilkey Avenue and, because it is a dead-end strip, it becomes a parking lot rather than a street. She stated that every car that enters Gilkey Avenue must turn around on private property or in the middle of the road. She asked the Board to grant this vacation.

Nancy Williams, Edison, lives across the Street from the former Morrison Lumber Yard. She asked if an engineer's study was done on the possible vacation of this road. She stated that there is much commercial access that goes back and forth on Gilkey Avenue, including 18-wheelers. She further indicated that many businesses in town utilize this area for parking.

Jeff Clark, owner of the Longhorn Tavern in Edison, stated that the former lumber store is being turned into a residence, and the owners are blocking access to Gilkey Avenue and are thereby denying parking to vehicles patronizing his restaurant. He concurred that there is limited parking available in Edison. He stated that vacating Gilkey Avenue will cause additional problems. He further stated that this is a neighborhood dispute that has escalated.

Jeff Osborn, Edison, stated that one of the issues is the lack of access and right-of-way to property adjoining Gilkey Avenue. He stated that there is not enough room to turn around on Gilkey unless the driver infringes on personal property. He indicated that any easements could easily be obtained so no one is prevented access to their property.

Commissioner Hart clarified that State law prohibits limiting access to private property.

Larry Bullis, 1203 MacTaggart, displayed a picture showing the subject area. He also showed photographs of the turn around area, which is basically non-existent. He explained the precariousness of the parking situation along Gilkey Avenue and in Edison generally. Mr. Bullis showed several additional pictures of parking situations, and indicated the need to resolve these parking problems.

Tony Berry, 565 and 568 Gilkey Avenue, stated that he owns property at the end of the street. He further indicated that this area has been this way for years and years. If this vacation is denied, he urged the Board to consider a vacation up to his property line and that he would grant Mr. Warren access through his property.

Doris Robbins, 583 Ewings Court in Edison, stated that this is a neighborhood dispute, and is a particular problem of traffic. She reviewed a map showing the area of the new sewer main running through Edison. She opposes the vacation, but stated that this dispute needs to be settled in a reasonable manner. Her main reason for opposition is that part of the Skagit County Clean Water District would be restricted for operation and

maintenance of the sewer line. Further, she indicated that the vacation would prevent one property owner from access to his property.

There being no further public comment forthcoming, Commissioner Anderson moved to close the public hearing. Commissioner Hart seconded the motion, which passed unanimously. The public hearing was closed.

Jan Keiser, Director, stated she would like an opportunity to review concerns and suggested tabling the requested vacation.

Commissioner Anderson stated that the Board cannot legally vacate a street that provides access to private property, but agreed that some mitigation is needed to solve problems in the area. He directed Ms. Keiser to work with the neighborhood and develop some solutions to their problems.

Commissioner Anderson moved to deny the vacation of Gilkey Avenue due to the legal ramifications of limiting a property owner's access to his private property. Commissioner Hart seconded the motion, which was unanimously approved. **(Staff will provide an appropriate Resolution at a later date.)**

6. Public Hearing – Consideration of Proposed Repetitive Loss Plan.

Sandy Corrión, Public Works Department Staff, explained the FEMA Community Rating System and the possible reduction in flood insurance to residents of Skagit County. She stated that Skagit County currently has the largest amount of policies of flood insurance in the State and the average policy premium is approximately \$410.34. By participating in this program, individuals can get credit for the activities that the County provides to increase flood awareness and prepare for flood events.

Ms. Corrión explained the procedures the project team went through to develop the draft Repetitive Loss Plan. She further detailed the activities the County promotes and participates in.

Ms. Corrión indicated that there will be a summary of needs required from the Board every year, asking for public testimony and written input. She further stated that this plan is in draft form and is available for critique and review. Ms. Corrión advised that the Plan is a constantly improving plan. She explained the possibility of receiving discounts should Skagit County's Plan be received by FEMA by October 1.

Dave Brookings, Surface Water Management Division Manager, noted the importance of working in partnership with the cities and towns throughout the County in this regard.

Commissioner Anderson suggested that Staff attend city council meetings in Lyman, Hamilton and Sedro Woolley to take advantage of combined efforts.

Ken Johnson, resident of Nookachamps, complimented Dave Brookings and Staff for the efforts they have done on this flood insurance reduction attempt. He stated that flood insurance is mandatory if a property owner is borrowing money through federally insured corporations and, such premiums are high. He stated that anything that can be done to reduce these premiums is much appreciated by residents of frequently flooded communities.

Mr. Brookings noted the importance of Ms. Corrión's contribution to these efforts.

There being no further public comment forthcoming, Commissioner Anderson moved to close the public hearing. Commissioner Hart seconded the motion, which passed unanimously. The public hearing was closed.

Commissioner Anderson moved to adopt the Repetitive Loss Plan as reviewed in draft form. Commissioner Hart seconded the motion, which passed unanimously. **(Resolution No. 16684)**

7. Signature – Notice of Road Closure of Allen-West Road, #36300, for September 29 through October 3, 1997.

Mr. Brookings presented a Resolution for notice of closure of a section of Allen West Road for September 29 through October 3. Commissioner Anderson moved to approve the Road Closure as presented by Staff. Commissioner Hart seconded the motion, which passed unanimously. (Resolution No. 16685)

8. Discussion – Surface Water Management Update.

Mr. Brookings gave the Board a brief update on construction projects of the Surface Water Management Division. These include South Burrows Bay, Robinson Road Bank Stabilization, and the Allen-West Road Project.

Mr. Brookings advised that Flood Awareness week is scheduled for October 20-25.

9. Miscellaneous.

There were no miscellaneous items for discussion.

**PLANNING & PERMIT CENTER – ROXANNE MICHAEL, DIRECTOR.**

1. Introduce Washington CTED (Community Trade & Economic Development) Planner.

Tom Karsh, Director of Planning, introduced Heather Balash, a growth management planner with the Washington State Community Trade & Economic Development.

Ms. Balash stated that she is here as a resource to the County to provide technical assistance and grant funding assistance. She stated that she will try to visit Skagit County as often as possible.

Commissioner Hart indicated the County's interest to work closer with CTED.

2. Introduction of Staff.

Jim Cahill, Senior Planner, introduced Allison Mohns, who is a new member of the Natural Resource and Water Quality division working on the Critical Areas Ordinance checklist.

Tricia Wright, Planning Staff, introduced Cindy Gauthier, who is filling in as a Receptionist for the department.

Jon Schmidt, Code Compliance Officer, introduced Diana Barnett, who is a new Code Enforcement Technician.

3. Discussion – Memoranda of Understanding with Cities of Burlington and Mount Vernon.

Kendra Smith, Senior Planner, explained that these memoranda have been in progress for over a year, and are in conjunction with the criteria of the Comprehensive Plan.

She advised that representatives from Mount Vernon and Burlington are present to answer questions.

Ms. Smith reviewed specifics of the Mount Vernon agreement as drafted. She stated that addressing was an issue and is still a concern of County staff that language be included to consider that addressing is in compliance with Skagit County Code.

Skye Richendrfer, Mayor of Mount Vernon, applauded the efforts of City and County staff in coming together in a cooperative effort over this Agreement. He stated that concern about addressing pertains to impacts on business people, and the costs incurred in changing addresses more than once. He stated that this is an area of great concern, but indicated that Mount Vernon is positive and anxious to move forward.

Commissioner Hart asked specific questions about areas that will obviously change addresses rather quickly and others that will not change for many years.

Mayor Richendrfer stated that as much as the City would like to have areas annexed, they know that is not always possible.

Commissioner Anderson indicated that in spirit the two sides are not that far apart, and he believes compromise will be met.

Commissioner Hart stated that many of the business in the area of South Mount Vernon are eager to be annexed by the City.

Mayor Richendrfer stated the need to find appropriate language that specifically identifies South Mount Vernon as a priority area.

Mike Woodmansee, County Administrator, stated that the issue of readdressing is largely one of maintaining the integrity of the methodology of databases, and is important in getting an ambulance to the right address. Until annexation is achieved, the South Mount Vernon area will be served by the County Sheriff, and appropriate fire district. He stated that it is important not to degrade emergency services, but there will always be quirks in these types of areas.

Commissioner Hart indicated that the public does not care if they are inside the City limits or in the County, but want to make sure they have appropriate 911 response in a reasonable amount of time. He stated that the public is paying the bill and wants and deserves more than adequate service.

Commissioner Anderson stated that in the short term, the County would be providing the services, but there must be a mechanism in place when and if the City were to annex the area. He stressed the need to put a plan in place now that would continue the service when that scenario is developed. He stated further that citizens need to be provided with emergency services on a consistent and responsive basis.

Mr. Woodmansee clarified that the only difference would be the legal jurisdictions involved.

Tom Sheahan, County Emergency Management Services Director, stated that there will be a great deal of confusion by dispatchers if a specific area is omitted. He stated that most of the confusion will be hard to address between now and occupying the new Enhanced 9-1-1 facility. He explained the particulars of how such confusion would be generated.

Commissioner Hart agreed with Mr. Sheahan that there will be issues before the new dispatch center is online, but stated his belief that these minor problems can be dealt with. He further indicated that no one should have to go through the process of changing their address more than once, and that there needs to be some form of stabilization.

Commissioner Anderson stated that there will be much more interaction between the cities and the County in the future. He further indicated that addresses should be changed only once, and Staff needs to work towards that end.

Mr. Woodmansee indicated that the need to develop a protocol in dispatch to avoid confusion.

Commissioner Hart stated that the bottomline is that the addressing process has been a well thought out and well reviewed process, but it is not perfect and there are political components. He concurred with Commissioner Anderson in that the County is mainly trying to serve and public and not make anyone go through additional address changes.

It was determined that Ms. Smith will be the point person on the continuing development of this agreement.

A brief discussion ensued on revenue-sharing criteria.

Ms. Smith then discussed the agreement with Burlington.

Margaret Fleek, Burlington City Planner, stated that businesses are the major financial concern. She detailed several areas of minor concern, and stated that Burlington's main interest is in expeditiously adopting this Agreement so that the City can proceed with three pending annexations. She indicated the City's general agreement to the concepts proposed. Ms. Smith indicated her willingness to make the minor changes suggested by Ms. Fleek. These items included adding language concerning nuisances and dangerous dogs.

Ms. Smith indicated that work would continue on these agreements.

4. Signature -- Personal Services Agreement Between TAG Real Estate Services and Skagit County Regarding the Hazard Mitigation Grant Program.

Mr. Karsh presented a Personal Services Agreement with TAG Real Estate Services for appraisal services regarding the Hazard Mitigation Grant Program. Commissioner Anderson moved to approve the Agreement as presented by Mr. Karsh. Commissioner Hart seconded the motion, which passed unanimously. (Contract No. 03634)

5. Miscellaneous.

Ms. Smith reviewed the progress being made on the development code.

**PUBLIC HEARING -- CONSIDERATION OF ISSUANCE BY SKAGIT COUNTY OF ITS LIMITED GENERAL OBLIGATION BONDS, 1997, IN THE AGGREGATE PRINCIPAL AMOUNT OF \$875,000 FOR COMPLETION OF A FAMILY RESOURCE CENTER.**

Commissioner Hart opened the public hearing.

Mike Woodmansee, County Administrator, stated that the public hearing is required by federal regulations. He read the public legal notice into the record. He also read a letter from the bond counsel to the County.

Judy Menish, Skagit County Treasurer, stated that she is very supportive of this concept and what is being proposed here today. She stated that, unfortunately, she must be the bearer of bad news. Ms. Menish stated that according to State Statute, all general obligation bonds must be reviewed by the Treasurer 30 days in advance of issuance of these bonds. Ms. Menish stated that she was not notified of this matter until 4:20 p.m. last evening, as the bond counsel had left the County Treasurer off of the distribution list. Consequently, the Treasurer has not been able to review the proposed documents in a timely manner as required by State law.

There being no further public comment forthcoming, Commissioner Anderson moved to close the public hearing. Commissioner Hart seconded the motion, which passed unanimously. The public hearing was closed.

The matter of the Treasurer's notification was discussed. Mr. Woodmansee stated that there is no requirement for the Treasurer's Office to sign or certify the Resolution as presented today.

Ms. Menish stated she had not had trouble in the past two years and that the reason the statute was passed was because Treasurers had had considerable difficulty when notification had not been made to them. Ms. Menish stated that her office has had no notification and that this is not appropriate or acceptable. Ms. Menish pointed out that the County needs to use this experience as a lesson in how bond reissuance should be handled.

Commissioner Anderson stated that Ms. Menish's point is well taken and that the Treasurer's Office should have been notified. He asked for clarification on the effects on the project of delaying signature on the Resolution for a sufficient amount of time for the Treasurer to review the documents.

Commissioner Hart asked for an explanation of the reason for the notification to the Treasurer, and if Treasurer's Office review is required, they should be allowed to complete that review.

Mr. Woodmansee stated that the County relies on bond counsel for review and process.

Ms Menish stated that there is reason for the Treasurer to review these documents to find errors and give feedback to bond counsel. She asked that her office's participation in this process not be belittled.

Commissioner Hart stated that he would like to see the appropriate steps taken and proper review by the Treasurer's Office as stated in the relevant RCW's.

Ms. Menish stated that she could review the documents in less than 30 days, but stressed the need to abide by the law.

Commissioner Hart asked for clarification of the ramifications of delaying the issuance of the bonds for any period of time. He offered to recess the proceedings for a short period of time to facilitate the Treasurer's concerns, and that the Resolution could be signed at a later time upon action by the Board. Commissioner Hart further indicated that the Board could proceed with the authorization of the lease agreement among the parties.

Mr. Woodmansee and Ms. Menish agreed that the Treasurer could review the document thoroughly within one week's time. He queried Susan Musselman, investment broker, as to the effects of delaying the bond issuance.

Ms. Musselman stated that the Resolution authorizes the distribution and official notice of sale to bidders, so those items would be delayed until the Resolution was approved. Further, this would push the sale back one week, and interest rates may not be as favorable as they are at this point in time. She explained a scenario that would give written notice to the Treasurer today, with the adoption of a Resolution next Monday or Tuesday. Further details were briefly discussed.

The Board indicated that this timeline was acceptable.

Mr. Woodmansee stated that there is a Family Resource Center Lease Agreement that can be signed by the entities present today.

A brief recess was taken to make some minor changes to the Lease Agreement.

Mr. Woodmansee presented the Lease Agreement for the Family Resource Center. Mr. Woodmansee briefly outlined the provisions of the Lease Agreement. Commissioner Anderson moved to enter into a Lease Agreement with the lessees of the Family Resource Center. Commissioner Hart seconded the motion, which passed unanimously. **(Contract No. 03635)**

**BID OPENING – PROCUREMENT OF MAINTENANCE MATERIALS.**

Charlie Sisson and Karla Farrell opened the bids. Mr. Sisson advised that these bidders be placed on an eligibility list to provide the County with maintenance materials for the following year. A complete list of those submitting bids is attached to this Record.

**WASHINGTON COMMUNITY ECONOMIC REVITALIZATION TEAM (WA-CERT) UPDATE.**

Don Wick, Economic Development Association of Skagit County, advised the Board that there have been no submissions to the list of projects, and therefore the previous list would remain in full force and effect. The Board concurred that the priority list should remain the same as last quarter.



**ADJOURNMENT.**

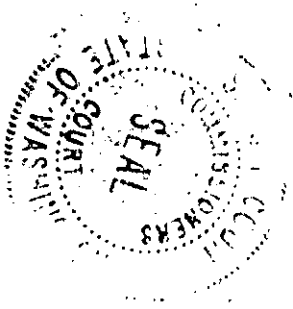
Commissioner Anderson made a motion to adjourn the proceedings. Commissioner Hart seconded the motion and it passed unanimously.
